## PRESIDENT'S MESSAGE

**A Light at the End of the Tunnel?**

In South Carolina, 29.7% of our citizenry had received at least one COVID-19 vaccine and 15.9% had completed their vaccinations, as of March 26. That's about 1.2 million people who have had one shot and 650,000 who have completed the series. Is that a light at the end of the tunnel?

Maybe. But a lot of people are still unprotected. We're making real progress, but we're relaxing COVID-related restrictions here and around the country at a time when we still have a long way to go.

In a March 29 White House briefing, CDC Director Dr. Rochelle Walensky pointed to recent rises in the 7-day average of daily new cases and in hospitalizations across the US and concluded "Right now, I'm scared."

**So, let's not take our ultimate success for granted just yet.**

Caution should still be the watchword: Wearing masks, avoiding medium-to large-sized gatherings, avoiding poorly ventilated spaces, and staying 6 feet away from others is still important until more people are vaccinated. CDC has an excellent fact sheet titled "[When You've Been Fully Vaccinated: How to Protect Yourself and Others](#)," which lays out what you can do after receiving the vaccine ... and what to avoid now.

We have avoided in-person NARFE chapter meetings for the past 12-months and continue to do so. At our last executive committee meeting, which was and will continue to be open to all chapter members, the general sentiment was that not all of our members have been vaccinated, and, even among those who have, many feel they will not be comfortable with a Damon's-style restaurant luncheon before September.

### **Continued: President's Message**

This year, we've kept our newsletter going for all but the month of July although we normally close it down in both July and August.

We're trying to start a more active Zoom meeting schedule. We've offered training. We could use more participants. Our membership has remained stable, but the number of active members who have joined the Zoom call has lagged behind our prior, in-person meeting attendance. Our March Zoom meeting drew 14 participants, compared to our usual 25 plus at Damon's.

COVID aside, there's plenty for NARFE to do. The magazine this month is asking NARFE members to contact their Washington representatives to support H.R. 82, the Social Security Fairness Act, which would fully repeal the Windfall Elimination Provision and the Government Pension Offset, which adversely affect the Social Security benefits of Federal retirees.

Similarly, it's asking for our active support for H.R. 304, the Equal COLA Act, which would provide FERS retirees the same cost of living adjustment as CSRS retirees.

How long have these issues – GPO, WEP, and unequal COLAs – been a thorn in your side? Time to raise them again with a new Congress?

Let's be productive during the remainder of our COVID-19 hiatus. That way we make sure that the light we see at the end on the tunnel is really blue sky, not an oncoming train.

## **Legislative Officer**

**Happy April..by now you should have received your stimulus money from the American Rescue Plan Act of 2021, and hopefully your vaccines, too, along with almost 100 million other Americans. And we have another month to file our taxes, as the 2020 tax deadline has been extended to May 17.**

**So far there has not been much activity in the legislation we are watching:**

- **Federal Pay and Benefits**
  - **H.R. 392: FAIR Act, to provide 3.2% pay raise to federal employees, referred to the House Committee on Oversight and Reform**
- **Support Reform/Repeal of WEP/GPO**
  - **H.R. 82: Social Security Fairness Act of 2021 (Jan 4, 2021)—seeks to amend title II of the Social Security Act to repeal the GPO and WEP; referred to the Committee on Ways and Means**
  - **H.R. 2337: Rep. Richard Neal has reintroduced H.R. 4540 Public Servants Protection and Fairness Act, which was not acted upon in the 116<sup>th</sup> Congress; it would recalculate and reduce the WEP reduction**

## **Continued: Legislative Officer**

- **Support Accurate COLA for Retirees**
  - **H.R. 304: Equal COLA Act—would guarantee that FERS and CSRS retirees would receive the same COLA increases, using the CPI-W (for Wages, not CPI-E for Elderly)**  
**Referred to House Committee on Ways and Means**
- **USPS--Protect Postal Retiree Health Benefits**
  - **The USPS Fairness Act, (S.145 and H.R.695) to eliminate the prefunding mandate for retiree health insurance premiums; supporters are optimistic for passage during this Congress.**
  - **H.R. 47: Would prevent USPS from being privatized**
