Legislative Officer Morris Zupan LEGISLATIVE REPORT AS OF 9/30/23

(Pending Legislation):

1. Social Security Fairness Act of 2023 (HR82, S597)

Repeals the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO).

Current Status: Per the October 2023 NARFE Magazine – 289 House Co-sponsors and 39 Senate Co-sponsors.

January 2023 was referred to the House Ways and Means Committee.

March 2023 was referred to the Senate Finance Committee (we have asked at both the National NARFE Headquarters and Our NARFE to contact our representatives asking for their co-sponsorship).

House: 290 Co-sponsors are needed for 25 days to get a floor vote on the act. There are two other 'acts' in congress that will eliminate or partially eliminate WEP/GPO, but they only have a low vote for further movement.

2. The Fair Cola (Cost of Living Adjustment) for Seniors Act:

The Act would use the Consumer Price Index for the elderly as the basis for the COLA retirement benefit. House Co-sponsors: 26

3. The Equal COLA Act:

The Act provides equal COLA amounts for the Federal Employees Retirement System (FERS) as it does for the Civil Service Retirement System (CSRS). House Cosponsors: 35

4. Other Pending Acts:

Do not directly relate to the retirees but one is related to a government shutdown. The Act protects Federal workers and contractors from a variety of civil service financial penalties during a lapse of appropriations such as a government shutdown. House co-sponsors: 2. Senate co-sponsors: 16.

Thank you for adhering to this request and all that you do to find an END to Alzheimer's Disease.

There is an interesting and important study that was conducted by researchers at the University of Texas Health Science in Houston, and other collaborating scientists (as named below) on the effect that certain adult vaccines may have on reducing the risks of developing Alzheimer's Disease. This study was conducted on older adults that were injected vaccines to prevent diseases such diphtheria. as pneumococcus, and tetanus, to mention a few.

The research team injected the patients in the trial study with the vaccines to prevent the mentioned diseases (and other diseases mentioned in the research paper). At the end of the second year of the study the researchers conducted a "looked back" on the patients, and on the 8th years of the study, they conducted a "follow up period."

The people that the researchers selected to participants in the study were dementia free. At the completion of the study the patients were 65 years old or older. The results of the study indicate that the vaccines administered to the patients may have a positive impact on reducing the risk of developing Alzheimer's disease. It is worth noting here, as these sciences stated, that the vaccines used in the study are adult vaccines that the CDC recommends for the prevention of the diseases named above.
