#### **President's Message**

OK, we made it to April. Hope Everyone had a Great Easter Holiday. The weather certainly held out considering how early the Holiday fell this year.

Again, this month, Damon's is not available to host our meeting, so we will meet again at Logans Roadhouse. Our member meeting will begin at the usual 11:30 start time. Those of us who attended the March 14 meeting, were treated to a presentation by Tammy Braithwaite on the workings of her charity "Gifts From the Heart". She detailed the plight of so many elderly citizens who have been dropped off at residential care facilities where family visitations are few if any. Tammy and her team visit these people, spending time with them, as well as bringing them personal care essentials.

The day after the March Meeting, we received our new and approved Linta-Leader has Chapter By-Laws. Cathy posted the updated/approved By-Laws to our Chapter website. In addition, since we last met, the SC Federation held its Zoom Conference on March 20. 2024. There were presentations from NARFE National President William Shackleford. Staff VP, Policy, and Programs John Hatton, and NARFE Region 111 VP Lynn Harper. President Shackleford spoke about the new initiatives to increase membership in NARFE. While still maintaining the previous instruction for Federations and Chapters to not overly swamp National Only Members with recruiting efforts, he did say that a new sponsored Marketing Effort is headed our way. At one point, NARFE membership had topped 500,000. However, between the 1980's and the present, it has declined by some 365,000 people. To start turning the tide in the opposite direction, NARFE has begun its initial efforts at reaching out to those members who have had their membership lapse. The effort does appear to be working. In 2022 some 14,305 memberships lapsed. In 2023, thanks to NARFE HQ follow-up inquiries, the number fell to 8,300. President Shackleford also reminded everyone that March was

NARFE PAC month. Everyone has received Emails, hard copy mailings, etc. explaining the importance of supporting this effort to

help protect the benefits we have earned against the efforts of those in Washington who would look to make cuts to them. He also spoke about the Upcoming FED CON, scheduled for August 18-20, in St. Louis. Early registration is now open, and again members should have received Emails on this subject. Unfortunately, there were some technical difficulties posting the slide presentations made by Mr. Hatton and Regional VP Harper. However, they are available on the SCNARFE.org Federation website if you would like to log on and go through them.

In addition to the above, National Secretary Treasurer Kathryn Hensley also addressed the group, and during her presentation informed everyone that she is running for the National President position. Blaine Lotz announced the results of the Federation elections, and New Federation Officers, Olivia Williams-President, Vice-President Kevin Toevs, Secretary Debbie Hill, and Treasurer Pat Whitely, were sworn into office by Regional VP Lyn Harper.

On April 4, NARFE hosted the first of what will be many webinars on the new PSHB program. Again, you can visit the National NARFE website and run through the recorded meeting at your leisure. While many specifics are not yet established in terms of cost, etc. the overall belief is that the new program will basically mirror the coverages, etc. Postal Employees/Retirees currently enjoy.

Anyway, that's it for right now, enjoy all the eclipse coverage on April 8, and I'll see you all on the 11th.

She will assist chapter members by providing information, answering questions, and offering guidance in navigating issues relating to federal pay and benefits, (Service Officer Guide FH-10, is available from National Headquarters) such as:

- A. Procedures governing the delivery of annuity checks.
  - **B.** Life insurance and health benefits.
    - C. Survivor benefits.
    - D. Change of beneficiary procedures.
      - E. Death benefits.
  - F. Social Security requirements.
    - G. State and federal income taxes.

Assists members in preparing documents associated with the above topics. Provide the F-100, "Be Prepared for Life Events" to assist members in managing their affairs; and keep up to date by reading benefits-related articles in NARFE Magazine and NARFE Insider.

# **Reporting the Death of an Annuitant**

Trying to prepare for the loss of a loved one makes many of us anxious, sad, and uncomfortable.

Here are some things to be aware of regarding your or your loved one's federal benefits when the unthinkable, but inevitable, happens.

- . The CSA (retiree) or CSF (survivor) number is needed when signing into OPM's Services Online account or when you call or write to OPM.
- . Report the death as soon as possible to the

  - Social Security Administration (SSA)
- . The funeral home will generally report the death to SSA as part of its services.
- . Call 800-772-1213 or TTY 800-325-0778

- . In-person if the local offices have reopened.

- . Call 877-888-3337 or TTY 877-5680
  - Federal Dental and Vision Insurance Program (FED\VIP)
  - Federal Long Term Care Insurance Program (FLTCIP)
  - **NARFE**
- . Call NARFE Headquarters at 800-486-8410 to report a death.
- Federal annuities or Social Security (SS) benefits Issued after the retiree's death must be returned to the Treasury Department. Notify the bank where the direct deposits are made so these payments can be returned. If a spouse or qualifying dependent was already receiving SS benefits based on the deceased's record, the benefit will automatically convert to a survivor's benefit.

### **VACANT POSITIONS**

# **Cathy Linta-Leader**

We have several vacant positions including the Alzheimer's Chair, Audit Committee, NARFE-PAC Chair, and 50/50 Committee. A brief summary of the responsibilities of each follows. Contact an officer if you are interested and/or need additional information.

<u>Alzheimer's Chair</u> – On a monthly basis, receive contributions from Chapter members and forward any monies to the Federation Coordinator; write an article for the Chapter newsletter. Oversee the Alzheimer's bank account. During meetings, provide monthly financial reports and give a brief report on any new Alzheimer's news releases. Schedule an Alzheimer's speaker/program for the November chapter meeting. Participate and plan fundraising events including the annual Walk to End Alzheimer's.

<u>Audit</u> – Perform fiscal-year audits of the Chapter Treasurer's and Alzheimer's Chair records and funds. Furnish report to the President and Executive Committee and inform members of findings. If an audit discloses any discrepancy, the Executive Committee determines the cause and corrections. Forward said report to the Federation and Regional Vice President. At least two members are needed.

NARFE-PAC - Promote our Association's political action committee by educating members on its importance, soliciting member contributions, and assisting Federation NARFE-PAC Coordinators in providing state recommendations for contributing NARFE-PAC funds to candidates in our district.

50/50 – Before the start of the Chapter meeting, sell 50/50 tickets to members. Tally the total monies received, have members pick two tickets and distribute 50% of the collection to the Chapter and the remaining 50% to two members. Document monies received and gave the Treasurer the Chapter's portion. At least two members are needed.

# **Legislative Officer**

# **Morris Zupan**

1. Several Bills have an impact on federal retirees. The one that has been given by far --- the most coverage in recent months through March --- is H.R.82/S.597: Social Security Fairness Act which repeals the Windfall Elimination Provision (WEP), and the Government Pension Offset (GPO).

January 18, 2024: NARFE detailed letter to the House Ways and Means Committee/Subcommittee on Social Security. The letter provides details on how WEP/GPO has worked to lower or eliminate Social Security for government workers who had jobs under Social Security and are receiving a government pension. The letter states that both President Biden and House Speaker Johnson support the Bill.

January 28, 2024: Congressional Report H.R.82/S.597 is among the top 10 most viewed Bills.

April 2024 NARFE magazine: H.R. 82/S.597 has 308 House Co-sponsors which means that it is likely to pass in the House when taken for a vote. The Bill has 50 Senate co-sponsors (half of the Senate).

- 2. Status of other Bills that impact federal retirees. There are three other pending Bills in Congress that will eliminate, or partially eliminate WEP/GPO, but they have relatively lower co-sponsors for further movement:
- a. H.R. 4583/S.2280 is one of them. This one expands and strengthens Social Security and improves the solvency of the Social Security Trust Fund while eliminating WEP/GPO. House co-sponsors 182, and Senate co-sponsors 4.

July 2023: Referred to the House Ways and Means Committee, and July 2023 referred to the Senate Finance Committee.

# **Legislation: Continued**

b. H.R.716. The Fair Cola (Cost of Living Adjustment) for Seniors Act:

The Act would use the Consumer Price Index for the elderly as the basis for the COLA retirement benefit. House co-sponsors 37.

c. H.R.866/S.3194. The Equal COLA Act:

The Act provides equal COLA amounts for the Federal Employee Retirement System (FERS) as it does for the Civil Service Retirement System (CSRS). House Co-sponsors 46. Senate Co-sponsors 7.

- 3. Paying tax on your Social Security:
- a. After three decades someone in Congress has submitted a Bill to eliminate ALL federal taxes on Social Security benefits starting in 2025. On January 25, 2024, Representative Angie Craig (D-MN) introduced the "You earned it, you keep it," HR 7804. As of the April 2024 NARFE magazine, there is no cosponsor report for this Bill.
- b. Changing the calculation for the Cost-of-Living Adjustment (COLA). Today the COLA uses the Consumer Price Index for urban wage earners for determining the COLA. On March 21, 2024, Senator Bob Casey (D-PA), Chairman of the US Senate Special Committee on the Aging, introduced Bill S3974. This Bill will include the higher inflation rate for health care as part of the increase for COLA (Personal Financial Planners include the higher health care costs as part of individual financial plans). Although, including health care costs as part of the COLA is a more accurate way of determining COLA'S. Experts say that if no strengthening of the Social Security Fund is made, the Fund will run low by 2033 causing a reduction of payments.

Coming Up For Air was written in 1939, before his rise to fame. # **BEWARE**

I know you have heard it all before, but one more time, let me reiterate a warning against scams that attempt to convince recipients to supply key credit cards, debit card, or other financial account information over the Internet or phone. The request may claim to be from credit card or debit card companies, or from the Federal Department of Homeland Security. Be aware that consumers should never supply their vital information financial the over Internet or by telephone to unfamiliar who initiate sources communication. "These scammers are preying on the trust that many people have in communications that appear to be legitimate." However. financial institutions legitimate generally do not ask for such important information in such a manner.

The fraudulent communications requests recipients to reply with money or information or to visit a particular website. Once routed to a website, consumers may be asked to input account numbers and Personal Identification Numbers under the claim that the user's address must be verified by the institution. Once a user has supplied the information, the scammers can access the consumer's financial accounts.

"The Internet is a wonderful tool that makes information and communication much more available. We all just have to remain vigilant in our battle against criminals "who will use it to steal from law abiding citizens.

If consumers suspect they have received a bogus credit or debit card e-mail, they should immediately contact the financial institution, or any other entity mentioned in the communication.

# **Just For Your Information**

Keep a watch out for people standing near you in the checkout line at retail stores, restaurants, grocery stores, etc. who have a cell phone in hand. With the new camera cell phones, they can take a picture of your credit card, which gives them your name, number, and expiration date. Identification theft is one of the fastest growing scams today, and this is just another example of the means being used. Please be aware of your surroundings."
